Dear Judge Peebles:

Mr. Moynihan told me you'd be the Judge handling the pending contempt charges and perhaps future charges. I was fortunate to have a very nice Christmas Vacation with my son, but must now return to the reform effort. In this type of matter I feel communications are very important to avoiding misunderstanding. During my last appearance I appreciated your willingness to listen in a thoughtful manner during our brief dialog. I wanted to personally update you on three items before my next appearance in Court.

**Conditional Release** - I want to inform you that I feel I may have violated those terms. Although I was unwilling to consent to the conditions, I do believe you did order me to do so. It is something I have been doing so long, that at times I forget it is a violation of State Law. I continue to drive with a suspended license. My license was not suspended for any drinking or other type of driving related issue – but because of back child support and I have not been able to resolve it. During my last appearance it simply slipped my mind during our discussion. It makes it impossible for me to comply with those types of terms and puts me in violation.

I write you not because I am a 'glutton for punishment' or that I 'like going to jail'. I do not. The very nature of what I am trying to do involves voluntary self-sacrifice to demonstrate belief in a fundamental right that we should be presumed FIT & EQUAL parents to our children. To have any value, I must be totally honest in what I do – for if I was deceptive and/or selfish, then I would genuinely be a 'criminal' and deserve jail.

**Returning to Federal Building on Jan 15<sup>th</sup>** - I have attached a recent email list message to our group members for activity planned for next Tuesday, Martin Luther King's Birthday. I hope it will explain why I must continue my efforts to achieve a local meeting between Sen. Clinton and parents hurt by the 'system'. It has always been my hope to get more mothers & fathers to join me. We would be much more effective and I hope that will occur next Tuesday.

**Asking for a new Judge** – You treated me with fairness, dignity and courtesy during my last appearance and I appreciate your forbearance in releasing me when you could have kept me jailed. I do not believe you have it yet, but I have asked Mr. Moynihan to prepare a motion asking you to recuse yourself from this matter for two reasons:

• As I'm sure you must know I asked Judge DiBianco to remove your wife as my assigned counsel for what I felt was poor representation. A neutral observer would have to say there is a good chance the Judge may find that objectionable, OR, find he has to be "easier" on the defendant just to show he

was not biased by what happened to his wife.

• I hate to even bring the next item up, since it is a private matter and I really don't want to know about it, but I heard from someone at the Federal Building that you are now divorced and I seem to remember your former spouse had pictures of your child in her office. Again, a neutral observer might say: Due to his divorce he was involved in a custody matter over his children. I don't know if he's happy/sad over what happened to his relationship with his kids. The defendant's 'motive' is a Civil Rights aspect regarding that very matter. The Judge might be influenced by that, e.g. Peebles went 'easy' on Murtari because he just got destroyed in his divorce and couldn't really see his own kid – OR – he got a satisfactory outcome and can't understand why the fuss about the system.

You could get a Federal Criminal record, a large fine, and 60 days in jail. I don't think it's likely, but if you are not ready for that -- please help in other ways.
